### **Minutes of the meeting of Churt Parish Council held on Wednesday 20 July 2022 at 7.30 pm.**

#### **22/62 Chairman's welcome**

Cllr Martin welcomed all to the meeting and invited the guests to speak.

Cllr Harmer updated us on SCC parking review and what might be done. Any objections are recorded.

Yellow lines should be painted on the opposite side of Jumps Road during the summer holidays. Some central government led changes to adult social care provisions. Top down but effects need to be looked at.

Need to look at detailed impact on budgets, second guessing next financial year at the moment.

Cllr Munro stated that WBC are merging with Guildford and having a joint chief executive.

Councils will stay as independent units. There are high hopes for monetary savings.

Much pressure over recent weekends on Frensham Ponds, lots of congestion and fire risks.

BOAT 520 Sandy Lane used as a race track for 4x4's. Cllr Munro in liaison with Sandy Lane Action Group. Solution is a traffic regulation order but this cannot be granted without looking at all other options. Trying to narrow the BOAT and raise level at either end using material already on site.

WBC recommended refusal of Lerryn planning application. Going to planning committee in August.

News in Nature on all social media channels.

Trying to encourage people to write to Jeremy Hunt regarding Farnborough noise pollution, to ensure the scope of the PIR is acceptable. Colin Shearn has sent out an update to all. He has heard back from Jeremy Hunt saying the scope of the PIR will now extend to 20 miles and will consider all affected aircraft below 7000 feet.

Cllrs Johnson and Spence attended the Waverley zoom meeting launching the Waverley Climate Change and Sustainability Supplementary Planning Document which is now out for public consultation until on 29 July. This will give guidance on 6 topic areas.

Will also focus on how to apply current policies to planning and clarify what information should be provided in relation to planning applications. Policies should be considered at the earliest stage of the application process. Document will be brought in front of full council in October. Much of this however will require a professional especially in relation to new developments. Unsure how it will apply to extensions.

Cllr Spence confirmed that WBC have agreed to fund the first stage of the appeal against Loxley oil exploration.
