22/52 Chairman's welcome

Cllr Martin welcomed all to the meeting and invited the guests to speak.

Jack Marriot was attending as he was interested in filling the casual vacancy. He has lived in Churt for many years and been heavily involved with many village organisations such as the sport clubs and Quinettes. He is a property lawyer by training but now has time to add value to the Parish Council. He appreciates the parking problems in Churt and the impact on local residents, especially related to the Sculpture Park. He is concerned about the speed cyclists come down the A287 and suggests we need traffic calming measures. He believes the speed van is of limited value.

Cllr Martin welcomed **Clir Munro** from WBC who won the recent by-election following the death of Cllr Brian Adams. He has lived in Frensham for 35 years and has been a councillor before at county and district level. He is aware of the major local issues relating to speeding, parking, and the noise from Farnborough Airport. Cllr Martin added that the planning issues at Borrow House Farm and the Sculpture Park are hot topics. There have also been recent problems with non-delivery from the WBC planning department. Clerk updated all on the recent Clerks meeting with WBC planning.

Cllr Harmer stated that bikes do not come under speed limit regulations as they do not have a speedometer. Regarding traffic calming measures any dug outs or width restrictors require street lighting and most villages around here are 'dark-sky villages'.

Police have limited enforcement resources, a change in the law would allow SCC to apply to the Sec of State to deal with moving traffic offences.

SCC has had its last meeting of the local committee for Waverley as they are keen to replace local committees. Cllr Harmer feels this will work in urban areas but not rural ones. There are 27 parishes in Waverley. Needs a meeting to discuss cross border issues.

Repair of the A287 from Jumps Road towards Pond Lane is on the Horizons project list hopefully for 2023 financial year. It is the duty of the County Council to put pressure on utility companies.
